## Staff Secondment Plan

### 1 Background

Opportunities for staff secondment shall be provided during activities of main importance in the demonstration projects, when convenient to both hosting and visiting participants. The procedure of matching occasions in URL work with interests of the other participants is foreseen to lie on the hosting participant, the Work Package (WP) Leader, who well in advance announces occasions and moderates programmes and contributions from visiting participants.

Budget and description of work are included as specific tasks under each WP 2, WP 3, WP 4 and WP 5. This plan summarizes those parts.

### 2 Prerequisites

When respective participant has identified the different occasions in respective WP and invited the other participants, they will acknowledge the information and take due steps to respond to the opportunities when being affected.

Each secondment is planned to be based on an agreement between the hosting participant on length of secondment and how many persons that will be included. The agreement will also address possible contributions like reviews of plans and procedures, exchange of experience and/or data, common evaluation of results, monograph on specific topic, or other interactive activities.

The hosting participant will inform of the formalities required for visiting persons at respective site and arrange necessary visitor's permits in due time prior to the arrival of respective person(s).
