A. Introduction

The third part of GEOSAF project (GEOSAF III) started in May 2017, is focusing on demonstration of the safety during both the operational and post-closure periods for geological disposal facilities for radioactive waste. The purpose of the event is to discuss the results of the GEOSAF III project, to examine the final draft reports "Managing Integration of Pre-closure activities and post-closure safety in the Safety Case for Geological Disposal" and "Operational Safety for Geological Disposal", and also to discuss the issues to be addressed in future activities related to safety of geological disposal of radioactive waste.

B. Objectives

The specific objectives of the meeting are:

- To deliver and discuss the presentations on draft reports with findings from GEOSAF III project. The presentation of draft report "Managing Integration of Pre-closure activities and post-closure safety in the Safety Case for Geological Disposal" is expected to be based on the national programmes for geological disposal and specifically existing safety cases in comparison to the concept of Design Target, Safety Envelope, As Built State. The presentation on draft report "Operational Safety for Geological Disposal" is expected to be mainly focused on specific aspects for which less provisions could be found in the IAEA safety publications (e.g. internal operation factors, basic considerations);
- To discuss an overview based on written comments on the draft reports from the participants to reports;
- To discuss potential improvements and contribute to the development of improved versions of the final draft project reports,
- To agree on principle revisions to the documents, develop a work plan in order to finalize and prepare two final draft reports for publication.

C. Target Audience

Member States are invited to designate one or more participant(s) for this meeting. Participants should be drawn from design and operating organizations, regulatory bodies, or technical support and waste management organizations involved in activities related to deep geological disposal of radioactive waste.

The IAEA would appreciate the designation of participants who were already involved in activities of the GEOSAF Part III project, the Working Group on the Use of Monitoring Programmes in the Safe Development of Geological Disposal Facilities for Radioactive Waste, MODARIA II project, the International Project on Human Intrusion in the Context of Disposal of Radioactive Waste (HIDRA) or the European Union Modern2020 project.

Member States are strongly encouraged to identify suitable women participants.

E. Participation and Registration

All persons wishing to participate in the event have to be designated by an IAEA Member State or should be members of organizations that have been invited to attend.

Selected participants will be informed in due course on the procedures to be followed with regard to administrative and technical matters. They will be provided with draft reports "Managing Integration of Pre-closure activities and post-closure safety in the Safety Case for Geological Disposal" and "Operational Safety for Geological Disposal" for review and comments to be submitted in written form to the Scientific Secretary by 24 September 2021.

F. Papers and Presentations

The IAEA encourages participants to give presentations on the work of their respective institutions that falls under the topics listed above.

Participants who wish to give presentations are requested to submit an abstract of their work. The abstract will be reviewed as part of the selection process for presentations. The abstract should be in A4 page format, should extend to no more than 2 pages (including figures and tables) It should be sent electronically to Andrey Guskov, the Scientific Secretary of the event (see contact details below), not later than **10 September 2021**.

In addition, participants have to submit the abstract together with the **Participation Form (Form A)** and the attached **Form for Submission of a Paper (Form B)** to their competent national authority (e.g. Ministry of Foreign Affairs, Permanent Mission to the IAEA or National Atomic Energy Authority) or their organization for onward transmission to the IAEA not later than **Submission Deadline**.
