1. Introduction

The main goal of European Joint Programme on Radioactive Waste Management (EURAD) Work Package (WP) 13 – Training & Mobility – is to establish and maintain the 'School of Radioactive Waste Management (RWM)'. The School of RWM acts as the executive body for all EURAD-related training and mobility actions. All information concerning the School of RWM and its activities is centralised on a dedicated website: <u>https://euradschool.eu/</u>. This website contains information on all the School's activities, namely: (i) the organisation of training courses, (ii) hosting the EURAD Mobility Programme, (iii) support for the EURAD PhD community, and (iv) hosting of webinars and other online activities. In addition, the website also contains information on WP13 activities and publications, a link to and information about the EURAD Roadmap, and a discussion forum.

This report provides an overview of all webinars organised by WP13 under the umbrella of the School of RWM. This includes data on the number of live attendees, the number of watched recordings and data on the feedback and mailing campaign accompanying each webinar. The latter provides useful information to continue to approve the webinars and our contact with the end-users (i.e. the attendees).

2. Lunch & Learn sessions

2.1 Background

The EURAD Lunch & Learn (L&L) sessions started in October 2020 as a consequence of the COVID-19 pandemic. They were set up to be short, informal, one-hour, online sessions aimed at all EURAD participants, but also all interested parties outside of EURAD. They serve as an approachable way to stay informed on work being done in EURAD, to share good practices, and to provide updates on latest developments in the field of RWM. Therefore, presenters can be EURAD partners, but also invited speakers from the Nuclear Energy Agency or the International Atomic Energy Agency, for example.

Practically, the L&L sessions are organised regularly by the Project Management Office (PMO) and WP13. Generally, they are organised on the last Wednesday of the month at 13:00 p.m. (Brussel's time). Exceptions can be made based on presenter preferences, or practical considerations.

2.2 Practical organisation

The L&L sessions are hosted via the online webinar platform Bigmarker (<u>www.bigmarker.com</u>). WP13 owns a license for this platform. The platform allows WP13 to:

- Send automated mails (invitations, reminders, post-webinar survey)
- Manage registrations
- Manage webinar and its recordings
- Report on registrations and attendance
- Share handouts (documents, video and presentations)

In practice, WP13 will create a specific webinar room for each L&L session. The registration link is distributed by the EURAD coordinator and is published on the School of RWM's website. Additionally, WP13 has created a webinar series in Bigmarker, which includes all L&L sessions [1]. The advantage of registering for the series is that interested attendees are automatically registered for all L&L sessions, including sessions that are added to the series at a later date. All registrants receive an automated reminder one day before the start of the L&L session.

Next step is that WP13 plans a test with the presenter in the week before the L&L to ensure that the presenter is familiar with the Bigmarker platform. This helps avoid technical issues during the actual L&L session.

During the L&L session itself, a representative of WP13 or the PMO serve as a moderator. All attendees can ask questions via the chat window. These questions are forwarded to the speaker by the moderator, during the session to be answered directly or after the session to be addressed by e-mail.

After the L&L session is closed, WP13 downloads and edits the recording. Then it is uploaded to both the Bigmarker platform and the WP13 YouTube channel [2]. The former triggers an automated mail to all registrants and attendees that the recording has become available. The latter is used to distribute the link via the School of RWM's website and EURAD's socials, i.e. Twitter [3] and LinkedIn [4].

4. Lessons learned from Month 1 to 36

The organisation of L&L sessions started in October 2020 and these were the first online activities for a large audience that were organised within EURAD. Since the organisation of the first session, some changes were made to the practical organisation based on feedback and the first experiences in organising these L&L sessions. As shown in Table 1, the number of attendees was rather low in the first five L&L sessions, but has increased since then. This is in part due to the lessons learned from the first L&L sessions.

The most important lessons learned are:

- Announce the topics and speakers as soon as they are known;
- Send reminders regularly, i.e. when the session is first planned, one month and one week before (at least), to the EURAD Community and via social media;
- Share announcement and registration information via LinkedIn, Twitter and EURAD's ProjectPlace;
- Listen to audience feedback.

Note that these lessons learned are mainly focussed on increasing and retaining the number of audience. There are no lessons learned on the format of the L&L sessions itself as all feedback from the audience on that has been positive. Examples of audience feedback include:

- 'How would you rate today's L&L session?': average score of 92%
- 'Were today's interactions during the L&L of good quality? (Yes/no)': Unanimously 'yes'

However, there is one major challenge that WP13 and the PMO have encountered: finding and attracting motivated speakers. While finding speakers in itself is not a problem, it is usually the PMO that contacts potential speakers. The number of 'voluntary' speakers from the EURAD community is rather low. This is an issue that is actively being worked on. Currently, reminders are posted in EURAD newsletters and during WP Leader meetings. An additional minor challenge is to increase the number of views of the recordings. As of now, no clear solution has been found.

5. Conclusion

Thirteen L&L sessions were organised between the start of EURAD and month 36 (i.e. end of May 2022). These L&L sessions cover a wide variety of topics, such as knowledge management, site selection procedures, and deep borehole repositories, to name a few. Since the beginning, audience feedback on the L&L sessions have been very positive. The main challenges are increasing and retaining the number of watchers and to find 'voluntary' speakers (i.e. speakers that were not directly asked to present a topic, but who volunteer to present a topic). Despite these challenges, the L&L sessions are a success, as indicated by the attendance rate. Therefore, WP13 and the PMO are committed to organise these sessions for the remainder of EURAD.
